## What's BEEN Happening Around The Villas Lately

Early this year, your Board identified three major maintenance

projects that we wanted to complete this year.


1. Repair the potholes in the asphalt roadway pavement.
2. Replace or repair portions of the perimeter wood fence posts that are "rotting" at the top.
3. Replace the joint material between the curb and driveways that has deteriorated and allows water through this joint into the subgrade. This has contributed to driveways heaving and the result is, in some driveways, a big difference in the elevation between the curb and driveway.

The asphalt repair and joint replacement, required between curb and driveways, was completed. Fence repairs between The Gardens and Rocky Ridge Villas has been completed. This involved trimming the top of posts, removing "the rotting material" and filling the void with a foam material, applying stain to the cut surfaces and installing a plastic post cap. This repair was considered to be the most cost effective solution to arrest the deterioration and extend the life of the fence. We have contacted our neighbours, The Chateaus, to solicit their commitment and involvement to repair of the fence between our developments. We have not had a response! We will contact our neighbours to the West and solicit their participation in our proposed solution to repair and extending the life of the fence.

We have engaged Pronto Calgary to flush out our main sewer line running down the middle of the road and connecting to the City system at Rocky Ridge Drive. This is planned for Nov. 1 (weather permitting). They will



not need access to any units, work will be done outside at the manholes. They will have big trucks working in the complex and we ask for your patience if traffic is somewhat restricted. Please not drive over their hoses if they get in the way, their technicians will re-position them as needed. Thank you for cooperation.
