OUR NEW BUDGET COMES INTO EFFECT SEPTEMBER 1st

A reminder to all owners that your condo fees are scheduled to increase by \$9.57 per month on September first. The Board approved the 2021 – 2022 budget in July and notification was sent out a month ago. The increase in monthly fee is due to increased insurance/appraisal costs, slightly higher management fees from ACMS and increased costs for maintenance. The new fee for every owner is \$402.74 per month.

WHERE IS YOUR \$402.74 GOING EVERY MONTH?

Distribution of your condo fee:

Contribution to the Reserve Fund	\$126.44
Landscaping/snow removal (includes parts and materials used)	\$110.54
Replacement cost insurance on our buildings	\$103.29
Administration (ACMS management fee, audit, document platform, printing/mailing, bank charges, WCB coverage)	\$ 28.59
Repairs and maintenance (building, fence and electrical)	\$ 23.07
Utilities (water, electricity and recycling/compost removal)	\$ 9.66
Fire hydrant inspections	\$ 0.41
Contingency fund (for unforeseen expenses)	\$ 0.74
All of this adds up to our condo fee of...	\$402.74

We felt it made little sense to have a new Board elected that would not have had input into the creation of this budget. It would also not be reasonable to have an August election of a new Board only to have them all resign again three months later at the November AGM.
